**APPELLANT GLIMPSES OF GUAM, INC.'S
ADMISSIONS OF FACT AND LIST OF
ISSUES**

The Appellant GLIMPSES OF GUAM, INC. (herein "Glimpses") submits the following Admissions of Fact and List of Issues.

Glimpses admits to the documents that are the Record of Procurement on Appeal submitted by the Guam Visitors Bureau ("GVB"). Glimpses expects that GVB will likely admit to admissibility of the documents that are the record of procurement.

Glimpses submits that the issues that will require evidence or argument are set forth in Glimpses' Motion and Memorandum Brief in Support of Summary Judgment and Reply Memorandum filed on May 7 and May 14, 2025, respectively. These include among others:

1. No individual bid of RIMS was ever submitted in response to the RFP;
2. GVB's purported Notice of a public state of emergency and necessity to protect substantial interests of Guam February 24, 2025 is void;
3. Does RIMS have the sole and individual right to receive the contract from GVB without an individual bid;

ORIGINAL

4. Is the contract between GVB and RIMS void as a result of the failures of GVB to offer the contract to the Manhita Team;

5. Is awarding a collaborative bid to only one non-bidder among several individual partners on a team bid is unlawful;

6. Is the exception to the automatic stay improperly invoked when no notice of the right to appeal was provided and distributed; and,

7. Is the enforcement of a two-day time bar without providing notice to Appellant arbitrary, capricious and contrary to constitutional procedural due process.

CONCLUSION

Glimpses submits the Admissions of Fact and Issues for briefing in the Trial Briefs as set out above.
