COMES NOW Appellant GLIMPSSES OF GUAM, INC. (herein "Glimpses") and the Purchasing Agency GUAM VISITORS BUREAU (herein "GVB"), and hereby submit their Stipulation to Settlement and Subsequent Order of Dismissal of OPA Appeal Nos. OPA-PA-25-002 and OPA-PA-25-006 With Prejudice Upon Satisfaction of Terms of Settlement.

1. The contract between GVB and RIMS dated March 4, 2025; that is filed as GVB0669-GVB0691 for Integrated Communications, Advertising and Events Support Services (the "Contract"), shall be cancelled and be null void and of no further legal effect as of June 9, 2025.

2. The parties stipulate that GVB shall as soon as practicable conduct a solicitation in accordance with the Procurement Code for needed marketing, communications, advertising, and events management services.
