16 COMES NOW Appellant GLIMPSES OF GUAM, INC. (herein "Glimpses") and  
17 the Purchasing Agency GUAM VISITORS BUREAU (herein "GVB"), and hereby submit  
18 their Stipulation to Settlement and Subsequent Order of Dismissal of OPA Appeal Nos.  
19 OPA-PA-25-002 and OPA-PA-25-006 With Prejudice Upon Satisfaction of Terms of  
20 Settlement.

21 1. The contract between GVB and RIMS dated March 4, 2025; that is filed as  
22 GVB0669-GVB0691 for Integrated Communications, Advertising and Events Support  
23 Services (the "Contract"), shall be cancelled and be null void and of no further legal  
24 effect as of June 9, 2025.

25 2. The parties stipulate that GVB shall as soon as practicable conduct a  
26 solicitation in accordance with the Procurement Code for needed marketing,  
27 communications, advertising, and events management services.

3. Glimpses consents and agrees to dismiss with prejudice Appeal Nos. OPA-PA-25-002 and OPA-PA-25-006.

4. The Appeals shall be dismissed with prejudice effective upon satisfaction of the Terms above and the date of the OPA's signing this Order.

5. The Appeals schedules shall be vacated.

6. Parties to bear their own fees and costs.
