GUAM TAX STRUCTURE

The U.S. Congress created the Territorial Government of Guam as a separate taxing jurisdiction by enactment of the Organic Act of Guam in 1950. Section 31 of the Act provides that the income tax laws in force in the United States shall be the income tax laws of Guam. In effect, the U.S. Internal Revenue Code constitutes the Guam Territorial Income Tax Law as administered by the Department of Revenue and Taxation (DRT).

The Department also administers other local taxes on Guam, including the Business Privilege Tax, Real Property Tax, Excise and Tobacco Tax, Liquid Fuel Tax, Use Tax, Hotel Occupancy and Short-Term Vacation Rental Tax and Automotive Surcharges. The Department also issues Real IDs, Driver’s Licenses, and Vehicle Registrations. The Insurance, Securities, Banking and Real Estate industries are also regulated by the Department. The national Motor Carrier Safety Assistance Program is also administered and operated out of the Department.

DEPARTMENT ACCOMPLISHMENTS

- ◆ Paid approximately \$129 Million in income tax refunds in a timely basis.
- ◆ Collected \$30 Million of outstanding taxes through a Tax Amnesty Program in FY2018.
- ◆ Implemented legislative initiatives affecting tax rate changes and collection programs.
- ◆ Achieved compliance with the Real ID Act of 2005.
- ◆ Improved customer service relations during the tax filing season.
- ◆ Continued building and strengthening of the partnership with the US IRS to keep abreast of developments and policies at the national level.

DEPARTMENT CHALLENGES

- ◇ The need to update department-wide Standard Operating Procedures on a continuing basis.
- ◇ A lack of access and resources for training.
- ◇ Inadequate funding to fill administrative positions and critical vacancies.
- ◇ Need for conducive work-place environment.
- ◇ Outdated computer system network
- ◇ Lack of opportunities for staff development, retention and promotion.
- ◇ Implementing and enforcing department related unfunded mandates.

CURRENT AND FUTURE OUTLOOK

The *Tax Cuts and Jobs Act of 2017 (TCJA)*, has created an adverse financial impact upon the Government of Guam in 2018 and beyond. The TCJA resulted in a significant revenue shortfall to Guam as individual and corporate income tax rates were reduced while the Additional Child Tax Credit (ACTC) was increased. The anticipated budget shortfall was off-set through increasing Gross Receipts Taxes from 4% to 5%, doubling property taxes on improvements exceeding \$1 Million or more, collection of delinquent taxes and adoption of strict austerity measures. Since the Department is mandated to collect taxes and fees that finance our government's operations our tax collection and enforcement program efforts have received much needed resources.

In the face of recurring challenges and added pressures on our work force and its resources, such as this massive revenue shortfall, DRT's staff continues to collect on both current and delinquent taxes. In June, a Tax Amnesty program was put in place that reduced outstanding taxes by \$30 Million through September 28, 2018. We also continue to process income tax refunds on a timely basis. Enforcement across all tax and regulatory fronts have intensified during the year coupled with an educational campaign to promote voluntary compliance. With utmost confidence, our committed, determined, and diligent employees will forge our department forward in achieving our overall mission.
