Hafa Adai Mr. Quenga,

Pursuant to 4 GCA §15409 (c), all government of Guam employees shall attend an ethics in government program and a refresher course at least once every four (4) years. New employees are required to attend this training within six (6) months of their employment, while existing employees are required to attend within thirty-six (36) months after the enactment of this Subsection.
